BERGY'S BABBLE: "APOCALYPSE YAY"

It's Advent!! <u>Happy New Year!</u> Christians are so lucky. We get extra occasions to celebrate beginnings and make resolutions: New Year's resolutions in December for the beginning of the Advent of our Lord, New Year's resolutions for the beginning of the Western calendar year in January, and New Spiritual resolutions in February to mark the beginning of Lent. This year Advent starts with the Apocalypse of Mark 13. HEADS UP!! There is a big difference between "The End of the World and an apocalypse. The ideas are confused. An apocalypse is a revelation. It is a disclosure of knowledge. It is a lifting of the veil. It is a <u>beginning</u>. Jesus says that in a time of revelation it is good to be alert.

One of the best things about The End of the World is that even though it has been calculated endlessly in an infinite variety of ways, all of the predictions have been 100% wrong. One of the big problems is that nobody knows what time it really is. Settling on a future date and time is real squishy. Which calendar and which method of measuring time is the only correct way? With all the myriad of different cultural calendars and ways of marking time, it seems exclusive, xenophobic to pick one and get all in a huff over it. For us this year is 2023. For Baha'ists it is only 180. The Buddhists call it at 2566. The Hebrew calendar says 5783. Islam says it's only 1444. Unix time is up around 1,704,075,408 or year 53. The answer to the question that doctors use to test patients for lucidity, (what year is it?) is kind of tricky. After all that is said, The End of the World and Apocalypse are two very different events. The first is an ending and the second is a beginning.

Nobody would ever say that the <u>POTATO</u>, was the End of the World. Consider the Apocalyptic Potato, a good thing, a new beginning, a wonderful stimulus to civilization imported to the world, and changing the world, thanks to the indigenous Native Americans, who cultivated it, and Columbian shipping and commerce across the Atlantic. Potatoes eased starvation, raised birth rates, promoted unanticipated population growth, enhanced craft specialization, and invention, expanded the marketplace, and fueled an Industrial Revolution. That's a lot of global impact for a lowly spud. Next time you eat a French Fry, ponder how it changed the world. What do you think? It wasn't the end of the world. It was an apocalypse, the beginning of a whole new world!

"We are stardust, we are golden...And we've got to get ourselves back to the Garden..." (Crosby, Stills, Nash and Young).

They were special, this enlightened generation. Their new vision would sweep away the rigid old order of their fathers with a 20th Century renaissance promising hope and progress for future generations. When their mantle of responsibility was assumed, a new world would be born. New thought spawned a youth culture embracing vegetarianism, herbal healing, communal living, sexual libertinism, and occultism. They cared about the environment and banned DDT, which was the equivalent of 3rd World Genocide. The unintended consequence? Death-rate score: DDT---zero, Unchecked malarial mosquito---millions. They emphasized health foods, promoted Earthdays, institutionalized child care, practiced pre-natal population control and euthanasia. Holy Cross Lutheran Church (HCLC) Minutes for Council Meeting - November 19, 2023

The November 2023, Church Council meeting was called to order by President Wendy Lambeth on Sunday, November 19, 2023, at 11:10 a.m. Pastor Berggren opened with a prayer.

In attendance were: Pastor Jim Berggren, Wendy Lambeth, Nancy Beamesderfer, Linda Cuzzort, Ricki Finstad, Julie Kilkenny, Wayne Schaper, Warren Schick, and Stephanie Walton. Reed Franklin and Tristan Walton attended as special guests.

The minutes from the October 2023 meeting were submitted by Council Secretary Julie Kilkenny and were approved by Council.

The **Treasurer's report** was presented by Ricki Finstad. October 2023 offerings of \$36,744, an increase of \$22,663 over September (this does include reimbursements and contributions for A/C unit and church office painting). He noted that actual 2023 offerings are running approximately \$9,600/month less than budgeted amounts. Expenses for the month of October were \$33,708, a \$12,896 increase over September (this included A/C and painting expenses). The checking account balance at 10/31/23 was \$37,702, not including restricted funds. Dr. Finstad provided details on several line items. He noted that there were dedicated funds in the Barnyard Animals account that need to be disbursed; Council discussed how to allocate these funds, and Dr. Finstad will process the check. Council approved the Treasurer's Report.

<u>Pastor's Report</u>: Pastor Berggren gave his report on activities for the month. He remarked that he had a busy month in the pastoral care area, as several parishioners had significant health events. He updated Council on several members on the prayer list. that the Reformation Sunday Potluck lunch and **WELCA** ThankOffering went well, and he appreciated the work done for Stewardship Sunday. He noted that he distributed directories to several new members. Pastor Berggren's other activities included preparing for worship services each week; making phone calls and visits to parishioners; providing counseling and ministering for prayer requests (coordinating with Deacon Donahue); outreach to the community; weekly Wednesday Bible Study; attending choir practice and various church ministry meetings.

Committee Reports and Old Business:

WELCA: Nancy Beamesderfer gave a brief update on WELCA. She noted the nice response for ThankOffering Sunday and for the Reformation Potluck lunch. They are waiting to hear about the results from Fratelli's Days fundraiser. Upcoming WELCA events include a Potluck lunch and Christmas Sing-Along on December 10th.

Improvements to Campus / Building and Grounds (B&G): Ms. Lambeth reported on projects around the campus:

- Issues with the A/C units continued, and another unit had to be replaced. She noted the contribution from the ELC toward this expense.
- Council discussed the damage to and subsequent removal of the porte cochere at the ELC entrance along the south driveway. A volunteer from one of the other churches supporting the Pantry hit a column, which collapsed the structure.

Alan Lambeth was working with the Eagle Scouts on campus that day and was able to work with the maintenance person from that church to take the structure down, making it safe for the ELC students and parents. Discussions continue on the best way to replace the porte cochere, the timing of which will depend on ELC class schedules.

- Due to the increased expenditure for the A/C unit, President Lambeth elected to have only the church office and hallway painted earlier this month, and not the other offices at this time. She expressed her appreciation that, because of contributions from Crafty Ladies and several congregation members, this project did not affect the HCLC budget. Council discussed modifications for lighting in the church office.
- Moon Valley Nurseries will do the installation of plants for the Westview courtyard garden on December 1st, which will be paid for with memorial funds.

President Lambeth gave a recap of **Stewardship Sunday**. She praised John Stokes for his temple talk at worship and for composing the stewardship letter to the congregation. She expressed thanks to Stephanie Walton for making stewardship cards to go with the crosses crocheted by Ms. Lambeth, to Julie Kilkenny for the bookmarks and pledge cards, and to Pastor Berggren for his letters and articles. She emphasized her desire that Stewardship Sunday also be an opportunity to thank all parishioners for their contributions at Holy Cross.

Other:

Ms. Lambeth stated that the **copier** lease expires in December 8th. Treasurer Finstad has been working to find the best solution for Holy Cross; he expects to make a final recommendation to Council before the deadline.

- There was a brief discussion of the wording for the plaque in memory of Ed Cooper. Ms. Kilkenny will order the plaque.
- President Lambeth remarked that the vacant Council position had not been filled.

New Business:

Boy Scouts:

- Reed Franklin presented his final report on his <u>Eagle Scout project</u> for Holy Cross (rebuilding the wood fence around the A/C unit adjacent to the west parking lot). He detailed his process for Council: raising funds, getting the required permit, coordinating the work for the thirteen (13) Scouts who helped him with the project. Ms. Walton explained that as a requirement for an Eagle Scout project to be approved by the Boy Scouts, in this case, HCLC Church Council would need to agree that Reed accomplished the goal as stated in his original proposal and that Council was satisfied with the results. A motion was made, seconded and unanimously approved (with a round of applause) that Reed Franklin's Eagle Scout project exceeded Council expectations.
- Tristan Walton presented a proposal for his Eagle Scout project, a refurbishment project for the playground. He presented his ideas to freshen up this first impression of the HCLC campus from the Wirt driveway, including 1) replacing the planters along the ELC classrooms with attention to the drainage issues in that area and installing trellises behind them, 2) refreshing peeling paint around the playground and on the play structure, 3) replacing a sticking gate hinge, 4) perhaps painting a mural on the side of the storage shed that could serve as a "photo op" background for student pictures, 5) changing out the existing trash can, and 6) refreshing the wooden ELC sign at the entrance.

• He would coordinate with ELC staff to ensure that their objectives were taken into consideration. He asked if HCLC memorial funds donated in honor of Tommy Neumann could be used toward this project, and Tristan would raise the remainder. Council approved this action. His goal is to have the project finished by spring break. Ms. Beamesderfer remarked on his achievement of the Order of the Arrow, noting what an accomplishment this is.

Building use Request:

- Council approved a request by Spring Branch ISD to use HCLC Youth Room for early voting April 22-30, 2023.
- Pastor Berggren noted that Sussy Terry has been working hard on the administration and schedule for the youth basketball teams. There was a brief discussion on some of the details. Ms. Walton recommended that Ms. Terry get a team photo from each team at the beginning of the season, so it can be displayed in the gym. She also suggested HCLC get an early start in planning a Sports Sunday. Council chose March 3, 2024.
- Mr. Schick proposed Council revisit building use fees after the first of the year.

President Lambeth noted that the Nominating Committee needs a Council representative on the committee. Council discussed who was eligible for this position, and this was deferred until the next meeting.

The December Council meeting was scheduled for Sunday, December 17, 2023 at 11:00 a.m.

Upon motion to adjourn, the meeting was closed with the Lord's Prayer.
