BERGY'S BABBLE: "SEEDS AND WEEDS"		
<p>Many seeds are smaller than the mustard seed and result in incredibly proportionally huge mature beings. You, for instance, all 60 trillion cells of you, are the result of one eager fertilized egg cell. A newly born blue whale gains 200 pounds a day. And you think you have a weight gain problem?</p> <p>The giant sequoia starts out as a seed weighing one three thousandths of an ounce. Yes, that one, that was planted, when Jesus was born, is 300 feet tall, 40 feet across at the base, weighs 6000 tons, and has such an active vascular system that in the spring you can listen to the trunk and hear the sap running up to the first branches, ten stories above you.</p> <p>The largest known creature on earth is a honey fungus individual, <i>Armillaria solidipes</i>, in the Blue Mountains of northwest Oregon. It is one genetic organism, covering 5 square miles. Sometime in the distant past, about 8000 years ago, it started out as a microscopic spore.</p> <p>Popularly, this parable of the Kingdom of God is viewed as the miracle of the disproportionate ratio of the size of a small seed to the size of the mature plant. That's only a part of the point.</p> <p>The mustard that Jesus was familiar with, is a botanical powerhouse, not the tasty, sweet domesticated mustard we grow for greens in the garden. It is a plant that is profligate, adventitious, opportunistic, persistent, tenacious, and invasive.</p> <p style="text-align: right;">... /// ...</p>

You can tear it up, but you can't kill it. It throws seeds everywhere, and they all sprout. The birds, enemies of all broadcast sowers, as illustrated in the parable of the *Sower and the Seed*, flock to it. The birds are undesirable elements in the agricultural world. Just like Christians in a pagan society.

In his work, *Natural History*, Pliny the Elder, (who incidentally, sailed 18 miles across the Bay of Naples to the foot of Mt. Vesuvius, to rescue people during its eruption in 79 A.D.,) wrote of the wild mustard, *aka* charlock, *aka Sinapis arvenis*, "With its pungent taste and fiery effect, mustard is extremely beneficial for the health, it grows entirely wild, though it is improved by being transplanted: but on the other hand, when it has once been sown, it is scarcely possible to get the place free of it, as the seed, when it falls, germinates at once."

It is pesky plant. It invades fields. It can change a domesticated field overnight. It is a weed somewhat like the Kingdom of God. If you don't know about this mustard plant, you would think that a bird seeking refuge in it, was a comforting, nesting image. On the other hand, Jesus's listeners would naturally think of the birds as enemies of the sown field. Given the unfavorable reference to birds, in the the *Sower and the Seed*, (those birds ate the seed, disrupting its yield) Jesus's parable suggests that the mustard shrub, once it takes root, much like the Kingdom of God, encourages the sudden presence of "undesirables": Those who are uncertified, unqualified and disruptive to the *status quo*. And it is all-you-can-eat blessings for them!!! As I feed on the seeds of the Kingdom of God, I am proud to be an undesirable! I am hungry for those seeds!!!

Just change one word in Pliny's *Natural History*, and Mark's Gospel point is made, item by item. Once again, paraphrased, "With its pungent taste and fiery effect, Christianity, at its best, is extremely beneficial for the health. Christianity can grow entirely wild. Christianity can be improved by being transplanted. On the other hand, when Christianity has once been sown, it is scarcely possible to get the place free of it. The seed of Christianity, when it falls, germinates at once."

This mustard tends to take over, sometimes where it is not wanted, it is hard to control, and it attracts birds in domesticated areas where they are not particularly desired. High school Coach Joe Kennedy, knelt alone for a quiet prayer on the field after his football games for 7 years. Nobody noticed. However, some people who didn't like prayer managed to get him censured and then fired. 8 years later, he won the case in the Supreme Court. And Jesus says, "Yes!! The Kingdom of God is just like that!" Persistent and invasive grace, and love, and joy as uncontrollable as the spirit that Jesus describes to Rabbi Nicodemus in John 3. The Kingdom of God is a dynamic and beautiful invasion. It works like beautiful seeds and weeds!

Holy Cross Lutheran Church (HCLC) Minutes for Council Meeting - April 21, 2024

The April 2024 Church Council meeting was called to order by President Wendy Lambeth on Sunday, April 21, 2024 at 11:00 a.m. Pastor Berggren opened with a prayer.

In attendance were: Pastor Jim Berggren, Wendy Lambeth, Jay Byerly, Ricki Finstad, Julie Kilkenny, Leigh Rothharpt, Hans Sunder, Warren Schick, Stephen Schulze and Stephanie Walton. Barbara Neumann and Tristan Walton attended as special guests.

Tristan Walton presented the final report for his Eagle Scout project, an extensive refurbishment of the ELC playground. This was accomplished over a 17-day period including the week of spring break. Items included in the project were refurbishment of the ELC building sign, repair of chipping paint and broken pieces on the play structures, repair and addition of planters, refresh of the memorial garden and addition of a “pizza garden”, drainage improvement along the side of the classroom building, enhancement of the concrete sidewalk by creating activity areas (hopscotch, caterpillar graphics, road graphics for tricycle traffic), addition of a mural on the storage shed, addition of an outside sink and replacement of aging gate hinges, and installation of a lending library box. He praised the efforts of the many volunteers who helped him, and President Lambeth remarked on his collaboration with the ELC teachers and attention to their requests. Council unanimously approved the motion to approve the submission of Mr. Walton’s Eagle Scout project.

The minutes from the March 2024 meeting were submitted by Council Secretary Julie Kilkenny and approved by Council.

The **Treasurer’s report** was presented by Ricki Finstad. March 2024 offerings were \$29,165, an increase of \$11,689 over February.

Expenses for the month of March were \$29,346, a decrease of \$3,680 from February. The March deficit (of expenses over offerings) was \$181. The checking account balance at 3/31/24 was \$18,474 not including restricted funds. Treasurer Finstad noted that he had to move \$30,000 from the credit union savings account into the checking account. He provided a summary of investments for this month and remarked that it may be necessary to move funds to replenish the checking account in the near future. His recommendation would be to use earnings from the Main Street stock for this purpose. President Lambeth asked for a vote (motion by Hans Sunder, seconded by Warren Schick) to approve this recommendation; Council unanimously approved this action. Council approved the Treasurer's Report.

Pastor's Report: Pastor Berggren remarked that it was a very busy month with Lent, Holy Week and Easter. He thanked everyone for their extra efforts during the season, including extra Holy Week readings, worship setup and food preparation. He enjoyed the mid-week Lenten services and lunches. He noted the passing of HCLC members Harold Braun and Laverne Pivonka.

His other activities include preparing for worship and Lenten services each week; making phone calls and visits to parishioners; providing counseling and ministering for prayer requests [coordinating with Deacon Donahue]; outreach to the community; weekly Wednesday Bible Study; attending choir practice and various church ministry meetings.

Committee Reports and Old Business:

Improvements to Campus / Building and Grounds (B&G):

- Alan Lambeth continued work on the sprinkler system around the church grounds.

- Pastor Berggren has been working on improving the lighting in the stairway behind the elevator.
- Council revisited the topic of the icemaker in the FLC kitchen. At a previous meeting it was suggested that, as a cost-cutting measure, HCLC discontinue the maintenance contract for the present icemaker and purchase a smaller icemaker that would not require this expense. However, the Bereavement Committee noted that this smaller machine would not have enough capacity for larger events (ex: funerals), and that requiring committee members to purchase and carry heavy bags of ice for each event was too burdensome. Mr. Schick recommended HCLC continue to use the current machine (Ms. Kilkenny agreed to do the semi-annual cleaning) as long as it was working, and should it break, the smaller icemaker could be connected and the matter revisited.

Food Pantry:

- President Lambeth presented a new proposal by the Pantry for its **proposed expansion**. A resident in the neighborhood, who is not in favor of the expansion, has presented his opposition at several meetings of the Hilshire Village Council and Planning Committee. Council had a lengthy discussion about possible solutions/compromises for this problem, and Ms. Kilkenny suggested that another meeting between HCLC and Pantry representatives, including the architect, was necessary. Ms. Lambeth will work to set up the meeting.
- President Lambeth noted that questions came up at the Hilshire Village Planning Commission meetings concerning the *written* agreement between the Pantry and HCLC, which does not exist at this time. (The Pantry's request to develop a **written agreement between HCLC and the Pantry** to outline the relationship and responsibilities of the two organizations as regards Pantry activities was originally discussed at the July 2023 Council meeting.) Ms. Lambeth distributed a draft previously provided by the Pantry for members to review and discuss at the next meeting.

Other:

- Council discussed several items regarding campus **security**, including upgrading the camera coverage. Ms. Rothharpt will research this.
- Stephanie Walton gave a short presentation on **VBS**. Council approved her request to order curriculum, which would help her in recruiting volunteers to staff the camp.
- President Lambeth reported the good news that the test for lead in the **ELC** water system was negative.
- Mr. Sunder requested an update on the interest in **Telge Lot 1**. Mr. Finstad reported that he was unable to reach the person who inquired about the property. Council briefly discussed that this lot was not on the market.
- Stephen Schulze agreed to coordinate a schedule to keep track of **inspections** for HCLC equipment, etc.

New Business:

- Stephanie Walton was elected as **Vice President** of the Church Council.
- Ms. Lambeth reported that the **FLC (Gym) kitchen** needs attention. She was approached by several members who would like to restart regular (quarterly) pest control services (beginning with clearing out closets and cabinets and filling in gaps through which insects enter), culling dishes and appliances no longer in use, and reorganizing supplies for the current needs of Holy Cross. She proposed hiring the custodian to do a “deep clean” before volunteers begin the task of reorganizing the area.
- President Lambeth noted that Gloria McGarvey has requested to relinquish her duties as **Usher Coordinator** and **Kitchen Coordinator**. Council discussed the need to publicize these openings and fill the positions.

- Ms. Lambeth reported that another Eagle Scout project is in the works. She expects to have more information at the next meeting.
- Council approved Tillie Remmert’s request to use **Memorial Funds** to replace grass and make improvements the sprinkler system.
- Council discussed a proposal by Ms. Walton to develop a “text blast” system to distribute HCLC news, which would be similar to and in addition to the current “email blast” system.

The May Council meeting was scheduled for Sunday, May 19, 2024 at 11:00 a.m.

Upon motion to adjourn, the meeting was closed with the Lord’s Prayer.

Minutes for Special Council Meeting – May 26, 2024

This special May 2024 Church Council meeting was called to order by President Wendy Lambeth on Sunday, May 26, 2024 at 11:10 a.m. Pastor Berggren opened with a prayer.

This meeting took the place of the regular meeting of May 19th, which was cancelled because of the power outage and damage from the storm on May 16th. The agenda was limited to discussion of the following items: 1) storm damage, 2) HCLC air conditioning and 3) Food Pantry expansion.

In attendance were: Pastor Jim Berggren, Wendy Lambeth, Jay Byerly, Ricki Finstad, Julie Kilkeny, Leigh Rothharpt, Hans Sunder, Warren Schick, Stephen Schulze and Stephanie Walton.

Storm Damage: President Lambeth commended the efforts of general contractor Noe Ibarra, Rene Romero Tree Service contractors, as well as HCLC members and staff, who all worked tirelessly to clean up the damage and get the church up and running. Although power was not restored at the church, Pastor Berggren held worship services on the Saturday and Sunday after the storm.

In her detailed description of the storm damage, Ms. Lambeth reported that the cost of emergency tree removal and cleanup was approximately \$9,000. There was extensive tree damage in the ELC playground area, with a large tree falling across the wrought iron fence and play structure, also causing damage to the circular sidewalk. There was significant damage to the Westview courtyard from fallen trees. This included damage to the roof and gutters, as well as the interior ceiling and walls of the Annex hallway, the portico and storage room adjacent to the Media Room, and patio pavers in the courtyard. Additionally, there was a downed tree from Telge Lot 1 that fell onto the roof of the house on Lot 2; the owner of Lot 2 cleaned up and hauled off the portion that fell on his property, but there was a significant amount of HCLC cleanup on Lot 1.

Repairs were also made to a section along the north aisle of the Sanctuary (both interior and exterior) after a leak was discovered after the storm. At the time of this meeting the church had not received an invoice for the construction costs. Ms. Kilkenny will get estimates for the playground fence repair and additional tree work.

None of the damages were covered by insurance, and Council discussed setting up and publicizing a “Storm Recovery Fund” so people can make designated donations to offset these costs. Stephanie Walton will look into setting up an online “Go-fund-me” type fundraiser.

Air Conditioning: President Lambeth reported on A/C issues in the Annex and the Gym. Some of the A/C units in the Annex and Youth Room are not working properly. There are 3 units servicing this area: 1) Unit #1 is working fine, 2) Unit #2, which was replaced in 2023, is not working properly and needs to be evaluated, and 3) Unit #3, which is over 20 years old, is not working. These need to be checked out by Martinez Services.

The A/C in the Gym (Family Life Center) has become problematic: at present one unit is not working at all and the other is marginal. President Lambeth distributed copies of the \$82,000 estimate by Martinez Services for replacement of the 2 A/C units, which were installed in 1978. She emphasized her faith and confidence in the owners and the quality of service and pricing given to Holy Cross. She remarked on the significant research put into the proposal, as this is a complicated replacement of an old system, requiring custom built curbs (foundations) and components. Treasurer Finstad stated emphatically that a second bid must be obtained for such a large expenditure. He and Steve Schulze will get bids from additional companies. Ms. Lambeth stated that time is of the essence, as the A/C has become unreliable, and it is imperative to be able to use the Gym for fellowship events and VBS.

Food Pantry: Pastor Berggren read from a letter he drafted offering a detailed perspective on the challenges of the proposed Pantry expansion. He noted that the obstacles affecting approval of the project by the Hilshire Village Planning Committee are between the Pantry and a Glourie neighbor, *not* Holy Cross. Although the original proposal to extend the current storage building along the western edge of the parking lot was acceptable to Council, several parishioners expressed to him that they were not happy with the new idea of putting the building in the middle of the parking lot. There was additional discussion and Council voted unanimously to approve Pastor Berggren's prepared written response that Holy Cross approves the *original* proposal to add a 40-foot expansion to the north of the current building. Pastor Berggren stated that it was his hope that the Pantry and the Glourie neighbor would find a mutually agreeable solution.

The June Council meeting was scheduled for Sunday, June 9, 2024 at 11:00 a.m.

Upon motion to adjourn, the meeting was closed with the Lord's Prayer.

STORM RECOVERY UPDATE

On May 16, 2024, a storm came through the Spring Branch area. Holy Cross was in its direct path, receiving torrential rains and winds of over 100 miles per hour.

A tree fell in the Early Learning Center playground, roots and all, crushing the canopy, upending the toy shed, and crashing through the fence. Another nearby tree fell and blocked the back entrance from Wirt Road.

Two trees also fell in the north courtyard, one hitting the Annex hallway roof and the other hit the roof of the Media Room closet.

Trees also fell on the grounds in other areas, including one on the Telge Property that landed on the roof of the neighbor's house. Debris from large limbs fell all over the campus. These are just the major issues.

I would like to say thank you to a few people. Rene Romero's Tree Service was here first thing Saturday morning to begin clearing the trees. Rene had injured his leg the week before, but he was here -in a wheelchair- to help his crew as best he could.

Noe Ibarra, who has done work for the church in the past, was also here first thing Saturday morning, to cover the hole in the roof and to begin what turned out to be major water damage in the ceiling and wall below. He repaired the roofs, interior and exterior walls, gutters, and a large hole in the brick courtyard that was punctured by the fallen tree. He also repaired water damage from wind-blown rain in the Sanctuary aisle ceiling, and cleaned and sealed the outer wall and roof to help prevent future leaks.

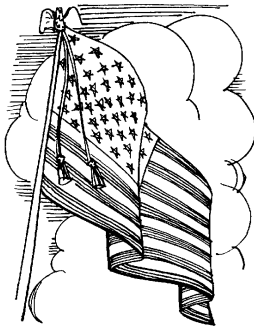
